<ul style="list-style-type: none"> ISQM1 	<p>Documentation has been added to address the requirements of International Standard on Quality Management 1 (ISQM1), required after 15 December 2022.</p> <p>In particular, the:-</p> <p>B03 Preliminary Engagement Quality Review;</p> <p>A21-2 Engagement Quality Review Checklist; and</p> <p>A21-3 Consultation Review documents have been updated where necessary.</p>
<ul style="list-style-type: none"> Fraud risk assessment and review documentation added 	<p>Documentation has been added and enhanced to ensure compliance with ISA (UK) 240, namely</p> <p>B34 Fraud Risk Assessment; and</p> <p>A46 Fraud Update and Evaluation.</p>
<ul style="list-style-type: none"> Audit team discussion and briefing documentation 	<p>New documentation (B41) has been added to record the audit team briefing (to take place immediately before fieldwork commences), in addition to the audit team discussion (recorded on B35 and which takes place towards the start of the planning process).</p>

<ul style="list-style-type: none"> ISA 315 changes 	<p>Update to Risk and Controls dialogues.</p> <p>Change of inherent risk scoring from High / Medium / Low to a range of 1 (Very low) to 5 (Very high)</p> <p>Addition of “Likelihood of Misstatement” and “Magnitude of Misstatement” fields to provide a risk spectrum</p> <p>“Proposed risk” feature enabled on FSA to provide a suggested Inherent Risk level for each assertion based on the risks identified in the file.</p>
<ul style="list-style-type: none"> Batch Update Tool (formerly Silent Update Wizard) 	<p>v8.0 of the Batch Update Tool is now available with new interface and enhanced capability with Working Papers 2022, to remove SmartSync conflicts.</p>
