Content changes	
• ISA (UK) 600	Although ISA (UK) 600 is only mandatory for accounting periods starting on or after 15 <sup>th</sup> December 2023, the changes have been early adopted as certain requirements in relation to component auditors are already effectively in place due to the requirements of ISQM1, and many of the changes are considered good practice.
	An option has been retained on B30-GROUP when assessing inherent and control risk of the components, where firms have decided not to early adopt the revisions.

	B30-GROUP Component risk assessment
New (optional) statistical sampling approach	A new sampling master form STATSAMP has been added where a statistical sampling approach in to be undertaken.

Removal of ISQC references	Procedures in PRELIM, A21-1, A21-2, A21-3, B01, B01-GROUP, B01-FREE, B02, B03, B11 and B12 amended.
